Parents' perception of Denny Sumargo's Curhat Bang Podcast on Youtube, the episode of the case of the death of Kediri students

Abstract. Youtube is an application that contains a collection of uploaded videos and has increased in popularity over the past five years, while Podcasts resemble radio programs because they contain audio content uploaded on YouTube. This study aims to determine the point of view of parents regarding the podcast content "Kediri Santri Death Case" on Curhat bang Denny Sumargo's Youtube channel which affects various views and mindsets circulating in the community, especially parents regarding the selection of educational institutions for children. This research uses a qualitative method by analyzing parents' perceptions through interview and observation data collection techniques. The conclusion of the research is that the parents' perception of the murder of students at the Tartilul Qur'an Islamic boarding school (PPTQ) Al Hanifiyyah has a positive response because the occurrence of the case depends on the supervision in the boarding school. Negative perceptions make their children traumatized and emotionally unstable in adolescence.

I.INTRODUCTION

Youtube is an application that contains a collection of videos uploaded by a person and can be used by various groups, ranging from young people to the elderly. YouTube is a video-based platform that has seen an increase in popularity over the past five years, according to statistics from the platform's website, currently YouTube has more than a billion users (David, Sondakh, & Harilama, 2017). YouTube has become a platform where many people compete to produce content in an effort to generate income, these people are commonly known as YouTubers or video creators. These YouTubers are engaged in a fierce competition to produce captivating content that will captivate viewers through a variety of creative and innovative ways (Cecariyani & Sukendro, 2018). YouTube can be utilized not only for entertainment purposes but also for educational purposes, as the content can be better structured and understood with its help. Currently, YouTube serves as a digital platform that allows for inclusive dialogue regarding sexuality and gender, accessible to individuals of various age groups and demographics (Susilowati, 2021). Live video views on YouTube allow users to conduct information searches. One of the platforms that someone uses to find information is a podcast youtube channel. In recent times, podcasts have gained significant popularity because they often feature interviews with the perpetrators themselves, in which they are accused of wrongdoing.

Simply put, a podcast is defined as online content that can be downloaded automatically to a computer or portable media device for a fee or as part of a subscription service. (Fadilah, Yudhapramesti, & Aristi, 2017). Podcasts resemble radio programs in that they contain audio content. The main distinguishing factor of a radio is its transmission time and frequency. In addition, podcast activities in the form of audio visual recordings can be enjoyed while doing other leisure activities. Viewers can also find entertainment while performing grueling multitasking activities, such as passing through traffic jams while tired. Podcasts can be used to unwind in any situation. Most

importantly, this podcast technology is unlimited and adaptable, allowing its use anytime and anywhere (Rosah & Aesthetika, 2022). Currently, podcasts serve as one of the mass media to disseminate information to a wider audience (Gogal & Tsabit, 2020). In addition, podcasts have several types (1) interview podcasts, this podcast uses interview methods like podcasters. What is done is to research and study the guests who will later be interviewed and make a list of questions.

in the form of monologues, conversations with yourself. Single podcast content can be breaking news, Q&A, or other personal opinion styles. (3) multihost podcasts: Podcasts usually feature two or more hosts, which makes them sound more lively than solo podcasts. Multi-host podcasts provide discussions where everyone presents different opinions or perspectives. It will be entertainment for listeners who love to watch the discussion. One of Denny Sumargo's youtube podcasts is an interview podcast type that provides a lot of information, one of which is the "case of the death of a student".

The case of the death of a student at the Tartilul Qur'an Islamic boarding school (PPTQ) Al Hanifiyyah, Kediri Regency, East Java. A student named Bintang Balqis Maulana (14 years old) died allegedly due to persecution carried out by his seniors at PPTQ Al Hanifiyyah. The chronology of Bintang's death, the pesantren said that Bintang fell from the bathroom. However, when the body was removed, blood poured out of the victim's coffin. The family also asked that the shroud be opened to see the bodies of the victims. After the shroud was opened, it turned out that the victim's face had been destroyed, his eyes were swollen, his neck was hollow, and there were many cigarette corners and bruises all over his body. Bintang's family also did not believe that Bintang fell from the bathroom and the family reported the death of her son to the police. The Kediri City Police then named four suspects. Some of the suspected perpetrators are under 18 years old. Based on this, the responsibility of law enforcement officials is to uncover illegal activities that result in the loss of human lives. However, community involvement is very important, especially for those who see, hear, or face such criminal acts (Abdullah, 2016). The victim's family asked for justice for the persecution case. One of the perpetrators of the persecution was his nephew or cousin of the victim, even Bintang's mother also entrusted her younger brother to be guarded while at the Islamic boarding school. An unexpected incident committed by the people closest to us. From several news circulating about the case, there is one of Denny Sumargo's Curhat Bang podcasts with the title "Santri Kediri Tev45, Initially Said to Have Fallen Out of the Bathroom, But the Body Came H417cur ?!". On the Denny Sumargo podcast, there is a lot of clearer and more detailed information about the case of the death of a student at the Islamic boarding school.

Denny Sumargo's channel is one of the YouTubers who is very active in uploading content such as podcasts, conversations with a series of celebrities. Denny Sumargo deliberately created his podcast as a forum for people to pour out their hearts. Denny is known for his good speaking skills and his relaxed yet informative style of interaction, making listeners feel comfortable and engaged in discussions. Many episodes contain inspirational stories from guests who have achieved success or faced major challenges in their lives, providing motivation for listeners to overcome their own problems. With a wide range of guests from different backgrounds, this podcast offers a variety of perspectives and insights that may not be found anywhere else. So the definition of the *CURHAT BANG* channel name where many people can clarify or explain is in their hearts without having to

be judged. One of the Podcast youtube channels uploaded on March 8, 2024, the audience reached 2.8 million, so news emerged of alleged persecution that led to the death of an underage student. The incident was caused by the boarding school who often ignored the matter of asking for news about his child at the boarding school. From this incident, there was a perception of parents in responding to a case of the death of a student at the boarding school. Denny Sumargo's youtube channel is a podcast that always brings in celebrities/celebrities. The podcast discusses several topics from daily life, a conflict, and even the fun that the informant himself has. Therefore, the public is already familiar with the CURHAT BANG Denny Sumargo podcast, almost all of Indonesia knows the channel to dig up factual information. Parents' perceptions regarding the case of the death of students at Islamic boarding schools have different perceptions. Because each individual has a different perspective on a problem that we know. Perception is the process of interpreting stimuli received by the five senses into an understanding (Nabila Hilmy Zhafira SM., Yenny Ertika SE., & n Chairiyaton SE., 2020). Cases of violence against minors have been increasing in recent times. Of course, as parents, we pray for the best for our children and grandchildren. When considering the death of a student at this pesantren, parents are faced with various points of view both positive and negative points of view. Many parents, especially mothers, have a bad perception regarding this case. This is because parents must be able to choose a pesantren that has operational permits and adequate facilities for their children.

Perception refers to the process of organizing, identifying, and interpreting sensations to create mental images (Baina Qodriani Marwa & Usman, 2023). So perception forms an individual's perspective or evaluation of something under consideration. The interpretation process begins with the reception of stimuli by a person's receptors (senses) and is further regulated to facilitate the recognition and understanding of the information experienced. These feelings and responses then give rise to two choices of feelings, namely pleasant or unpleasant feelings (Azahari et al., 2022). Therefore, Perception is a series of active processes. Perception is formed from three main stages according to Wood and Mulyana, namely:

1. Stimulation or Selection

Stimulation is the arrival of a sensation. Sensation is the earliest stage in the reception of information (Mulyana, 2002, p.59). The stimulating sensation caused attention or attention from the communication participants. What we pay attention to is what this section is called. The giving of attention/attention involves all of our conscious minds (DeVito, 2007, p.81).

2. Grouping

After selecting what information to digest, the communication participants will organize the information. The organization is by grouping information against the understanding that the communication participant has. This grouping is made to prepare for the next process, namely the interpretation or assessment of information/messages.

3. Interpretation-Evaluation

The next process is interpretation and evaluation. These two processes are inseparable. At this stage, conclusions are formed. This stage is very subjective and influenced by various personal factors (DeVito, 2006, p.60). Adler and Rodman divide the personal factors that affect a person's judgment into five things: previous experiences, assumptions about a person's behavior, expectations (whether or not they support their expectations), knowledge possessed, and the person's feelings (mood) (1991, p.35). These five factors are things that can be traced to what is in the mind of a patient at RPS when assessing the communication messages he receives.

4. Storage (Memorizing)

The results of the interpretation and evaluation that have been carried out previously will be stored in the memory of the communication participant. So that at some point they can reuse the interpretation in the future (DeVito, 2007, p.83).

5. Recall

Someday someone may need to reinterpret what he has done before. At this stage, the results of the interpretation became a new treasury for him and a new source of reference for the Cognitive Schema. This recall process assures that the information he gets is well processed and can be used as a new schema in his thinking (DeVito, 2007, p.84).

In perception, there are also two types of differences, namely negative perception and positive perception. (1) Negative perception is a response that is the opposite of the object. The root of a person's negative perception lies in his dissatisfaction with the perceived object, his lack of knowledge or understanding, his limited exposure to the object, and the negative beliefs he adheres to. This depends on the individual's satisfaction with something that is the origin of the recognition. Perception of an object involves individual knowledge and direct experience of the object. This negative perspective arises from an individual's interpretation of something in a detrimental or detrimental way. This means directing attention to the unfavorable aspects of what is considered negative. A bad outlook can impact several aspects of a person's life. Negative perception can be interpreted as a person's tendency to have a dislike or unfavorable opinion about something they perceive. (2) Positive perception refers to being conscious and having a comprehensive understanding of knowledge and information obtained and used consciously or unconsciously. It

refers to the recognition and support of an action or thing recognized by others. Positive perception is a cognitive process in which a person interprets or understands information in a good way. Optimism refers to the capacity of individuals to see favorable aspects of a particular situation or object and recognize the presence of positive possibilities in any personal event or meeting.

This study aims to find out the perspective of parents regarding the case on the podcast which affects various views and mindsets circulating in society, of course on parents regarding education for children. The method used in this study uses qualitative descriptive. Researchers concluded that there were more negative perceptions than positive perceptions of parents in viewing the content of Denny Sumargo's podcast about cases of persecution of students through the perceptions of each of them. Researchers are interested in studying the perception (parents) of the death of their students by analyzing descriptively. Who actively listens to or watches Denny Sumargo's podcast. What is meant by the word active here is the active use of online media and other sources, because each person and the audience in general have different specific goals in choosing the means and needs for receiving information. Therefore, researchers need insights from listeners (parents) that match the information in the podcast. From the perception of parents, we will find the results we are looking for in these problems. Therefore, we need clear, factual, and accurate information.

Research related to podcasts that have been conducted previously that are referenced in this study include research conducted by Muhammad Rifqi Slamet and Tia Muthish Umar (2023) entitled "Bandung Students' Perception of Deddy Corbuzier's Podcast Content". This study uses qualitative methods and conducts perception analysis to provide several research findings, namely (a) Bandung students' perception of the content of Deddy Corbuzier's podcast causes cognitive, affective, and behavioral consequences. (b) in assessing Deddy Corbuzier's behavior as a "host" on podcasts, students' perceptions are in line with the journalistic code of ethics in the Republic of Indonesia. (c) Deddy Corbuzier has shown professionalism, transparency in communication, and maintained a kind and friendly attitude towards his sources. (d) Deddy Corbuzier's podcast faces obstacles in mass communication, including psychological and cultural limitations. The difference in the research is from the Youtube Channel and the case researched by the researcher and in terms of goals in each audience has its own different needs taken from listeners.

The second research related to podcasts that has been conducted previously so that it becomes a reference in this study is the Melly Anjani (2023) research entitled "Student Perception on Deddy Corbuzier's Podcast Broadcast of the Salary Segment of DPR Members on Youtube". The researcher used perception analysis to ensure that the research findings were consistent in terms of how salaries and benefits were seen in the YouTube show of Deddy Corbuzier's Podcast, especially in the Salary section of the House of Representatives. If the funds are large, it is important to have a monitoring mechanism. The Salary Broadcast of Members of the House of Representatives is a valuable tool for the people of Indonesia to assess the performance of Members of the House of Representatives and eliminate bad perceptions related to them. The difference can also be seen from the Youtube Channel and in terms of the cases studied by the researcher.

The third research related to youtube perception that has been carried out previously which is a reference in this study is that conducted by Rd D Lokita Pramesti Dewi and Udi Rusadi (2023). Titled "Youtube Perception of Deddy Corbuzier and Indonesia: Diversity Literacy to Gender and

Sexuality Politics". This study uses qualitative analysis methods and uses perception theory to reveal that gender equality for women in Indonesia in general is still lacking. Gender inequality poses a major obstacle to the advancement of human rights and social justice principles in Indonesia. It is important for all Indonesia citizens, regardless of gender, to get equal rights and fair treatment. The emergence of gender disparity has a very bad impact on society and even the nation as a whole. The difference in the research is in terms of the purpose of understanding how the current social reality of Indonesia society in looking at gender and sexuality political issues on Deddy Corbuzier's podcast. And it has differences from the Youtube Channel and the case studied by the researcher.

The fourth research related to youtube perception that has been conducted previously which is a reference in this study includes the research of Kent Benedict Zefanya Agushar and Gregorius Genep Sukendro entitled "Perception of Purwokerto City Youth Perception of Dark Joke Content on Youtube Social Media (2022)". This study uses a qualitative descriptive method to convey research findings that reveal differences in perspectives among adolescents in the city of Purwokerto, including positive and negative assessments. Initially, favorable views provide valuable information. The main purpose of dark joke comedy content is to entertain, while also containing useful information or discussing various themes. This is achieved through the use of dark humor in comic content shared on social media platforms. YouTube has a beneficial influence on its viewers. In addition, the bad view of dark humor comedy material comes from its sensitive characters, so it is unacceptable to many people. Dark humor in comedy material can shape a person's mindset, and it may have a bad impact.

The fifth research related to the perception of podcast content that has been carried out previously which is a reference in this study, Muhammad Misbahul Huda (2020). With the title of research Tattoo Perception on the Deddy Corbuzier Podcast Youtube Channel with Hendric Shinigami Broadcast January 2020. This study uses a qualitative approach and applies Roland Barthes' semiotic theory so that it finds that the perception that associates tattoos with negative things is just a myth, this is studied based on Barthes' semiotic theory. So it is important to understand that the presence or absence of a tattoo on a person should not be used as an indicator to perceive their moral character. So it is necessary to examine the benefits and recognize them first, after which to build a perception.

II. RESEARCH METHODS

This research uses a qualitative method. Qualitative research aims to gain a general understanding of social reality from the perspective of participants (Suryaputri, 2020). The data obtained will be processed by emphasizing the depth (quality) of the data rather than the quantity (quantity) of data (Waluyo et al., 2022) This study uses a parental perception analysis method, where the audience interprets and understands the issues presented in the podcast material in different ways. This can be seen from the knowledge and thoughts of the audience themselves.

The data collection techniques used in this study are conducting interviews and making observations. The informants in this study were 10 parents who lived in Surya Asri 1 Housing in Gang Block A7 Odd and A8 Even located in Buduran, Sidoarjo. Parents became informants in this study because there were considerations for children to choose a good educational institution and

also had several positive and negative opinions from the cases in the study. have children at the elementary school and junior high school levels, with the following details: (1) Irin's mother's name aged 45 Ardhan's child name in grade 2 junior high school (2) Anjar's mother's name aged 38 Azzam's child name in grade 6 elementary school (3) Alifah's mother's name aged 30 Nadhif's child name in grade 5 elementary school (4) Ratna's mother's name aged 50 Nawa's child name in grade 3 junior high school (5) Anis's mother's name aged 47 Fadhel's child's name in grade 3 Junior High School (6) Khotim's mother's name, age 40, Ikhwan's child's name, 2nd grade junior high school (7), Tanti's mother's name, 33, Maheera's child's name, 4th grade, elementary school (8), Nita's mother's name, age 42, Haidar's child's name, 6th grade, elementary school (9), Via's mother's name, age 31, Amran's child's name, 2nd grade elementary school (10), Ismi's mother's name, age 29, Aiswa's child's name, 1st grade elementary school.

In addition, the researcher used secondary data obtained from social media platforms and websites. Primary data was obtained from the results of the research object directly by observing watching the Denny Sumargo podcast channel. Secondary data is obtained from sources of journals, books, and websites related to the researcher's problems. Secondary data was not obtained from the results of direct interview observations.

III. RESULTS AND DISCUSSION

Parents' Perception of Murder Committed by Santri on Their Own Friends at the Tartilul Quran Islamic Boarding School (PPTQ) Al Hanifiyyah.

From the results of this research, it is carried out with stimulus or selection, this method is carried out by selecting informants who are directly involved or informants who are considered to have the ability and understand problems related to research and also parents who like to watch podcasts on Youtube channels. And the informants we choose parents who can be trusted can provide information, views, and broad understanding of the case of the death of students at the Kediri Islamic boarding school. The second stage is to group parents who have experiences like what happened to the nearest sodara. And with these two differences, it makes the grouping when listening to Denny Sumargo's podcast. In the third stage, the evaluation of the results given by the informant after listening to the podcast. Evaluate by dividing two perceptions, namely between negative perceptions and positive perceptions given by informants on the podcast being studied. The fourth stage of storage is how to remember or store the informant's memory of the podcast issue that is being researched to form a mental framework that will affect the way we view cases of bullying and maltreatment in children in the future. The fifth stage remembers that when there is the same issue as the case being studied, the informant will recall what he perceives regarding the case and recall the experience experienced with his closest relatives or the many issues that give a negative perception in the informant's mind.

Regarding the opinion or perception of parents, how to respond to the act of persecution ending in killing students is a heinous thing or not allowed in religion. The following is Nurul's response:

"The murder that occurred at the Kediri Islamic Boarding School should immediately ask for justice for the occurrence of the case. The hope of parents at home to enroll their children in Islamic boarding schools is to explore religion. Instead, he died tragically" (interview on March 26, 2024). The same is the opinion of Irin's mother about how to respond to the case of persecution that ended

in death to a student at the Kediri Islamic Boarding School as follows:

"In my opinion, Islamic boarding schools must now be stricter in supervising their students so that there will be no more incidents like this" (interview on March 26 2024)

For the welfare of children who attend Islamic boarding schools, it is very important to support their spiritual, social and academic development. The protection of children in the pesantren is the responsibility of the pesantren. The response from Mrs. Anjar regarding the murder case in a student who has experience with her child also attends the Islamic boarding school is the following response:

"In my opinion, killing children has crossed the line is already a crime, so the perpetrators of murder must be severely punished, we must provide proper education to children in Islamic boarding schools and provide good religious knowledge, not through violence or murder' (interview on March 27, 2024)

Persecution refers to deliberate actions to cause pain or cause physical damage to the body of another person (Lamintang & Lamintang, 2018). From the results of the interviews obtained, it is interpreted that the lack of supervision on the part of the boarding school and the application of the attitude of the students is not reflected in daily life or in the boarding school or outside the boarding school. According to the response from Mrs. Alifah as follows:

"The dedication given from Islamic boarding schools should be applied in daily life. Because we as parents provide a good education where every day I pay attention with love and affection. I was educated from childhood to adulthood, I put it in the Islamic boarding school so that my child would avoid juvenile delinquency at this time" (interview on March 27, 2024)

There are various variations of techniques in parenting children. So, it is quite difficult to generalize it because each parent has a different personality and characteristics in educating children. Every child has also a character that is not the same as other children. So, each individual has a different character. Response from Ratna's mother as next:

"If I educate children wisely and disciplined. I also give a statement to my son if we are not wrong we must respond wisely and evade that it is not our fault and if we are wrong, we must admit the mistake and apologize. Honest behavior must also be applied to children from an early age because honesty is the key to success. We as parents must also negate if we have to do it from a young age so that we have a sense of responsibility for ourselves" (interview on March 27, 2024)

From this murder case, it gives a sense of trauma to parents and children for their future. If they want their children to go to school at Islamic boarding schools. The following is the response from Anis's mother:

"With a lot of negative news about Islamic boarding schools lately, I am reluctant to send my children to Islamic boarding schools even though the Islamic boarding schools have education that is more oriented towards religion. However, I also have limitations to know the news of my son at the Islamic boarding school mess. Yes, the emergence of negative news about the boarding school is a lesson to further increase supervision of students" (interview on March 28, 2024)

The positive response to the problem of the murder case on the student. The following is the response from Mrs. Khotim:

"In my opinion, all of it comes back to each of us. The existence of confusing problems with this Islamic boarding school gives us learning to choose an appropriate boarding school and whether or not it has a permit. We also went directly to the Islamic boarding school to check that the Islamic boarding school was safe and that there was no negligence in supervising students in their daily lives" (interview, March 28, 2024)

Parents will provide good facilities for their children. The response from Mrs. Tanti regarding the response of the victim's mother to the victim when she needed help is as follows:

"Yes, indeed, the response from Bintang's parents (the victim) cannot be blamed because yes, after all, the victim's mother makes a living as (ART) where this mother's job is rarely to monitor mobile phones. And his mother had also tried to pick up the victim but the victim assured her mother that she did not want to be picked up because she would soon be on holiday to go home. There, the star mother was relieved by the star's answer and there were no strange thoughts on the star" (interview March 28, 2024)

Parents also have the right to respond to this problem wisely, namely this murder case against the perpetrator who persecuted and ended up dying against his own friend who should have respect for each other and respect each other, as conveyed by Nita's mother:

"This case is very outrageous, Bintang's mother (the victim) must be given justice for the occurrence of this case. Which parent is capable of this murder happening? From the explanation of the victim's mother on the Denny Sumargo podcast, Alm Bintang's body had blood and there were traces of smoking on his body. I as a mother listened to this news very heartily and I became afraid to send my child to an Islamic boarding school far from my parents" (interview on March 29, 2024).

Every parent, especially a mother, has a response from Mrs. Ismi, how to see the facilities and supervision in supervising their children who are studying at the Islamic boarding school so that there are no repeated cases that happen to students:

"As parents, of course we have a great responsibility to be actively involved in the educational life of our children, including in Islamic boarding schools. We have to be more intensive in communicating with the children, listening to their experiences, and being good supervisors even though we are not always there. Especially to the pesantren, we must further supervise the students in the pesantren". (interview on March 30, 2024). The physical and psychological development of the victim causes shock and requires healing to build confidence in the face of difficulties. Children who experience violence need more love and attention from those around them. Children need the attention and kindness of siblings, friends, and teachers to cope with their trauma and prepare for their future lives. So, as a parent, please pay more attention to your children better and supervise your association wisely. Because in this day and age, promiscuity and violence against the closest and unknown people have occurred a lot. As a result, we must be able to take care of ourselves to avoid this.

Factors Causing the Murder of Students at the Tartilul Quran Islamic Boarding School (PPTQ) Al Hanifiyyah.

From the youtube channel podcast "Curhat Bang Denny Sumargo" has provided more detailed information about the death of students at the Islamic boarding school. This helps parents to understand the cause and effect of the case accurately. The information obtained from this podcast

gives a real confidence in parents. Unmistakable news circulating on social media such as TikTok, Twitter, and Instagram. Parents as members of society in general, can learn to distinguish facts and opinions so that their knowledge can be accessed by the wider community. On the podcast, Denny Sumargo brought in the mother of the victim's student named Bintang to clarify the case of this problem. Therefore, many parents perceive the incident as a negative perception such as There is a perception that the case shows a failure in preventive measures and handling cases of violence in schools, and that the authorities or educational institutions are not responsive or proactive enough in preventing violence from occurring, This case can affect parents' perception of the quality of education in certain schools, raising doubts about the effectiveness of school supervision and management, parents do not choose Islamic boarding schools for their children's education after seeing the podcast because of fear and as parents are worried about trauma and emotional instability. This negative perception can reflect parents' dissatisfaction and concerns about various aspects of handling and the impact of the case, as well as its long-term effects on the education system. Parents give a negative perception because one other thing from the management of the boarding school is too negligent in providing news or information about children in the boarding school.

By watching the podcast, it will be easier to find out the causes and consequences that occur in the problems of the students who died. In the podcast, Denny Sumargo provides more accurate and factual information. Therefore, a lot of negative content is circulating on social media with distorted news and hoaxes. Denny Sumargo's podcast is a source of real information because it directly brings in the speakers.

There are several positive perceptions given to parents towards the content of the podcast The case can increase awareness among parents about the dangers of violence in schools. They may see an opportunity to educate themselves and their children about the importance of self-care and reporting violence, This case can underscore the importance of child welfare and make society pay more attention to the safety of children in educational settings. Parents may feel positive about the increased focus on their children's well-being, Parents may appreciate the courage of the families involved in the case to speak up and express what happened. This can be considered an act of courage that gives encouragement to other parents to be more active in dealing with similar issues.

The case that occurred at the Islamic boarding school which began with the victim has been repeatedly abused. It seems that there was a misunderstanding between children and the incident of abuse was repeated. The four suspects were charged with Article 80 Paragraph 3 of Law Number 23 of 2022 as amended regarding child protection, Article 170 of the Criminal Code concerning the use of violence against people or property, and Article 351 of the Criminal Code. The Criminal Code on the use of violence was repeatedly charged. Coercion to commit a criminal act that results in death.

The incident of persecution of Bintang (victim) on Friday, February 23, 2024. The four suspected perpetrators of the death of the student in Kediri are MN, 18 years old from Sidoarjo, 18 years old MA from Nganjuk Regency, 16 years old AF from Denpasar, Bali, and 17 years old AK from Surabaya (quoted from tirto.id). Bintang Balqis Maulana died and was killed by the perpetrator. The police believe that the victim was abused repeatedly.

It seems that there was a misunderstanding between the perpetrator and the victim, so that the persecution was repeated many times.
